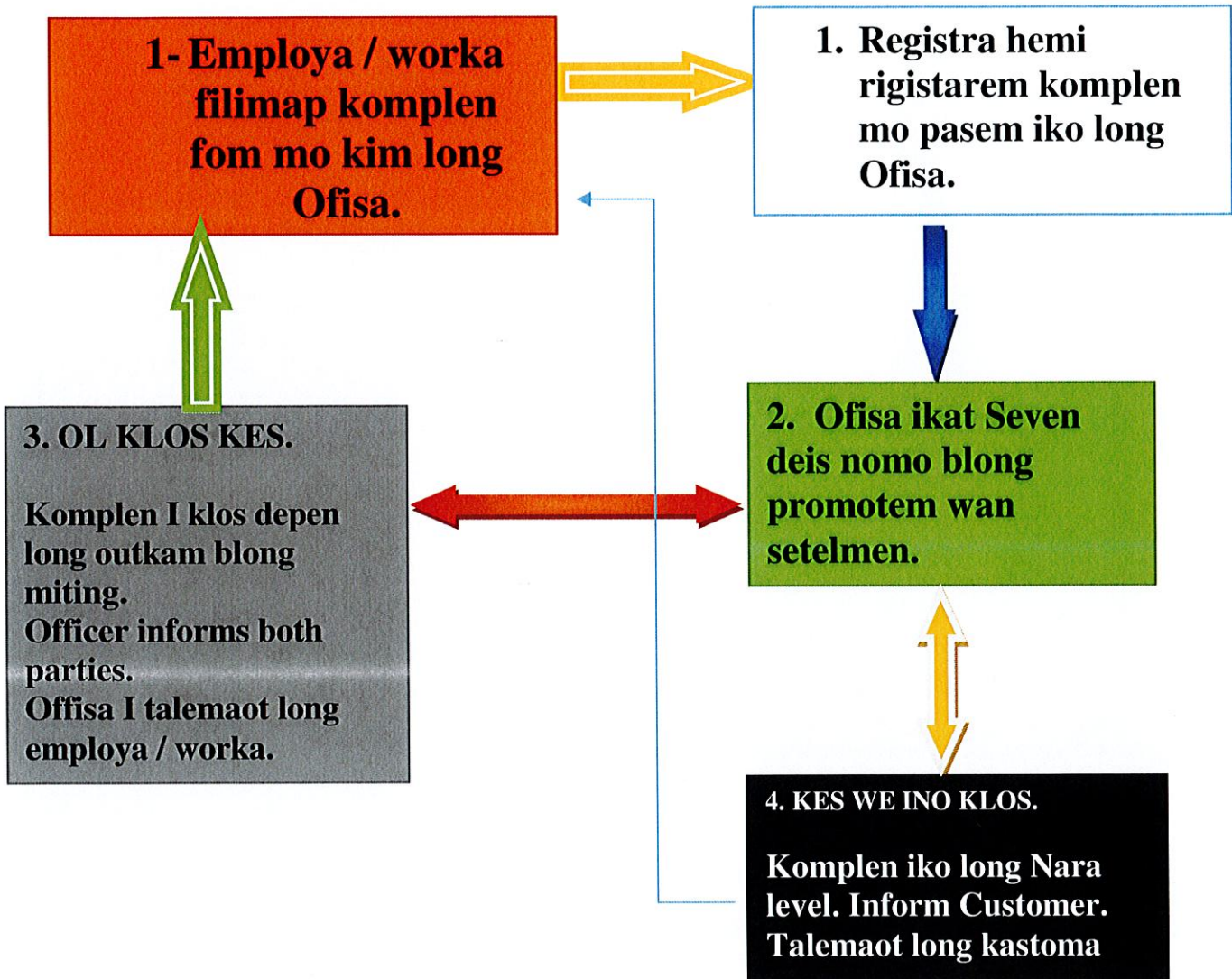
- 1- Kastoma I wraetem komplen blong yu long komplen form mo passem iko long officer.

- 2- Ofisa bae I work long komplen blong yu wetem employer blong yu blong Seven working deis nomo.

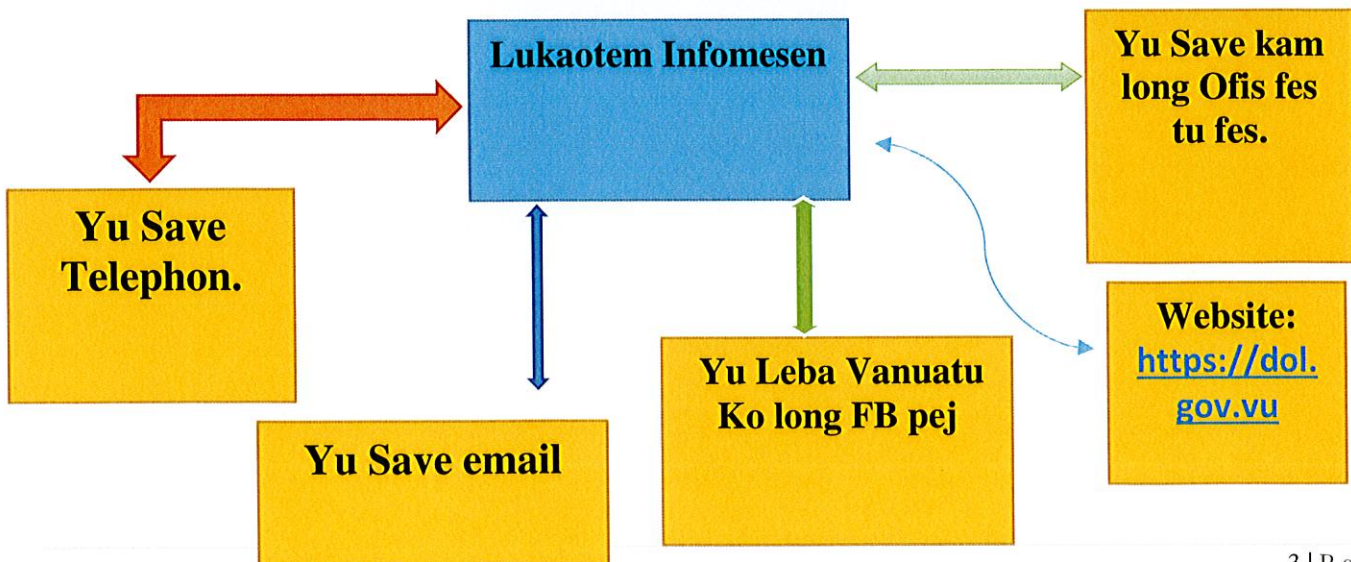
- 3- After long Seven deis sipos Officer I solvem komplaint bae hemi klosem komplen blong yu.
